Registration Policies

- Registration accepted by mail, online or telephone with a charge card, or in person at the Community Center until the first day of class/activity, unless otherwise specified.
- Checks are payable to "City of Brea."
- Questions: Classes: 714-671-4428; Sports: 714-990-7171; Tiny Tots: 714-990-7631.
- Sliding scale non-Brea resident service fee added. Proof of residency is required at registration.
- All registration on a "first-come" basis. Waiting lists are used if additional staff or facilities become available.
- All classes subject to change or cancellation if minimum enrollment size is not met.
- Full refunds/credits available for courses cancelled by City or Instructor.
- Participant-requested withdrawals must be made at least 3 days prior to the start of activity and are subject to \$5 processing fee.
- Withdrawals/refunds are NOT available once a program begins.
- Credit card transactions will be credited to the original card used.
- Refund checks will be mailed for cash or check transactions. This process takes 3 to 4 weeks.
